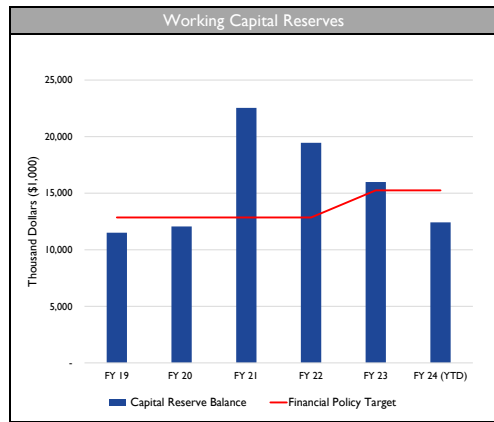
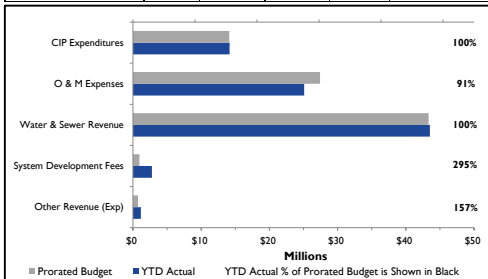
SYSTEM COMPLIANCE VIOLATIONS

Operating Permit Violations: Sanitary Sewer System Overflows due root growth (October 2023), contractor damage (July 2023), contractor error (November 2023), inflow and infiltration (January 2024), and pipe failure (February 2024).
 Operating Permit Violations: System Bypass due to equipment failure during high flow event (February 2024).

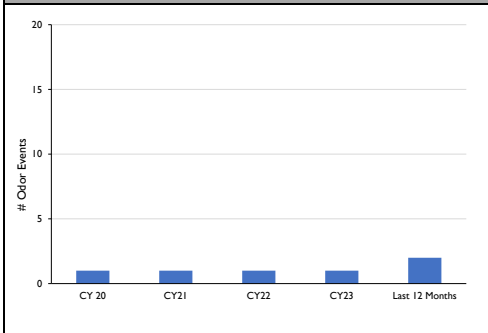

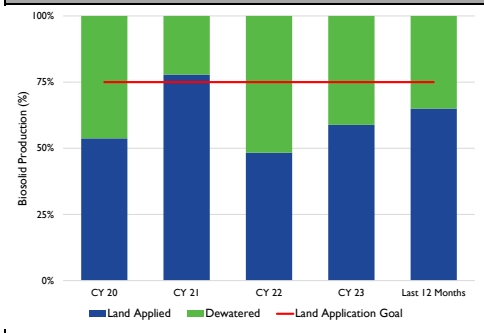
ODOR ELIMINATION

Number of Odor Events at Wastewater Treatment Plant



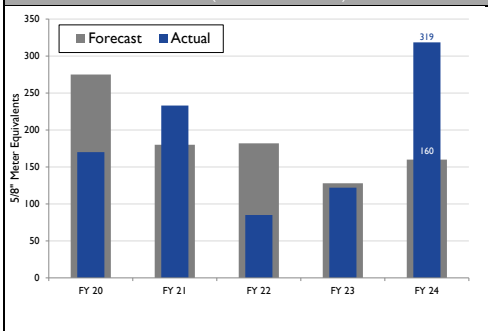

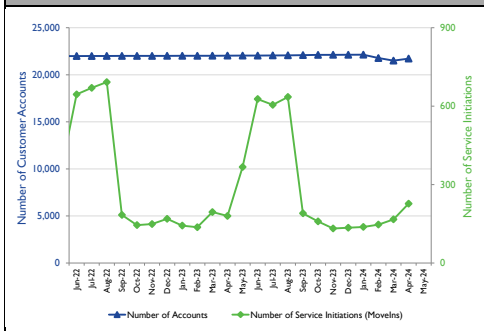

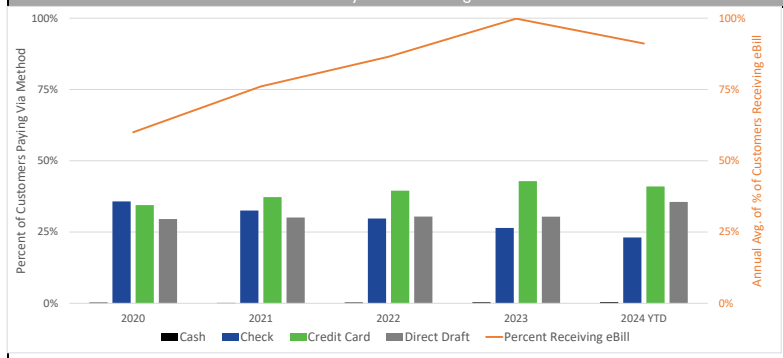

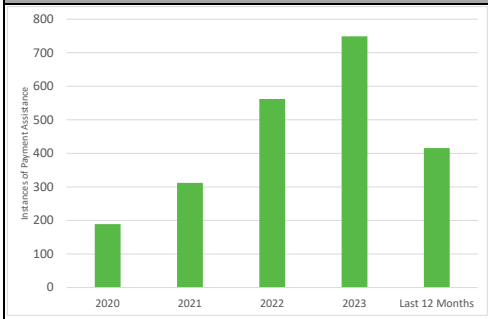
Customer Accounts and # of Service Initiations



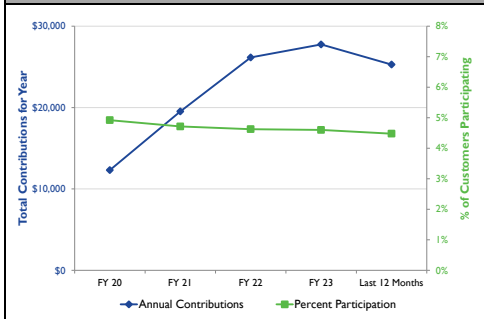

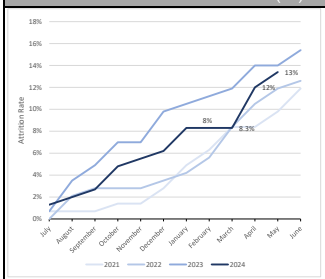

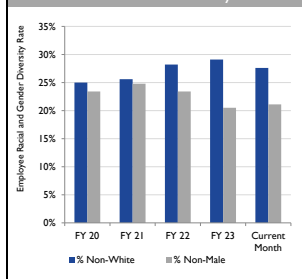

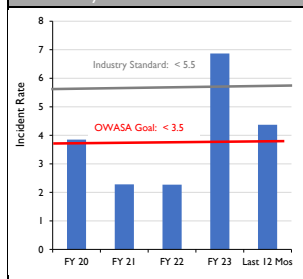
Cumulative Annual Attrition Rates (FY)



Racial and Gender Diversity Rates

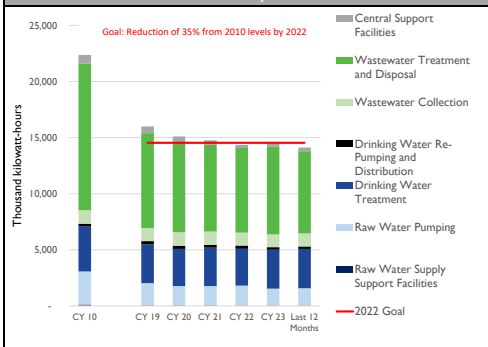


Safety Record - Incident Rate
